- Bills to law: President may veto or sign in 10 days, or the bill is returned to Congress for 2/3rds vote in order to overcome the veto. If more than 10 days passes before returning the bill, the bill automatically becomes law.
- Pocket Veto – President does not sign (“holds in pocket”) and Congress has already left, results in a veto.

Medicare - Social Security Administration

If you have higher income, the law requires an adjustment to your monthly Medicare Part B (medical insurance) and Medicare prescription drug coverage premiums. We call the additional amount the income-related monthly adjustment amount. This affects less than 5% of people with Medicare, so most people don’t pay a higher premium.
